5. Electronic bids must be submitted to the office **Kanakai Municipality** through PPMO website www.bolpatra.gov.np/egp or before *above mention date and time*. Bids received after this deadline will be rejected.

6. The bidswill be opened in the presence of Bidders' representatives who choose to attend at before *above mention date and time* at the office of **Kanakai Municipality**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **Rs. 9,00,000** deposited at **dharauti account No. 1470300000003000002** on behalf of of Kankai Municipality, **Surunga** Nepal Bank Limited or bid bond authorized from a recognized 'A' Class commercial bank of Nepal, which shall be **valid for minimum 30 days** beyond the bid validity period.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
