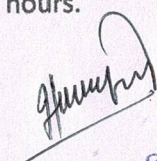

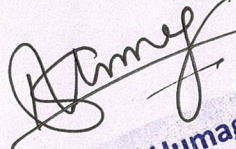

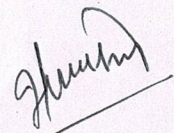

4. **For SQ Works:** Complete set of Bidding documents may be purchased from the office of Kanakai Municipality, Jhapa and the office of Kanakai Municipality by eligible Bidders on the submission of a written application along with the copies of updated company/ firm registration certificate, Tax Clearance certificate of F/Y 2081/82, updated business registration certificate copy and upon payment of non-refundable bid documents fee of NRs. 1,000 till 2083 Ashoj 15 during office hours.
5. **For NCB Works:** Sealed must be submitted to the office Kanakai Municipality, Jhapa by hand 12 PM on 2083 Ashoj 30. Bids received after this deadline will be rejected.
6. **For SQ Works:** Sealed must be submitted to the office Kanakai Municipality, Jhapa by hand 12 PM on 2083 Ashoj 16. Bids received after this deadline will be rejected.
7. **For NCB Works:** The bid will be opened in the presence of Bidder's representatives who close to attend 1:00 PM on 2083-06-30 at the office of Kanakai Municipality, Jhapa. Bid must be valid for 90 days from the bid submission deadline and must be accompanied by the bid security which shall be valid for 30 days beyond the validity of the bid.
8. **For SQ Works:** The bid will be opened in the presence of Bidder's representatives who close to attend 1:00 PM on 2083-06-16 at the office of Kanakai Municipality, Jhapa.
