- 1. **Kanakai Municipality** invites sealed bids or electronic bids from Nepalese eligible bidders for the Construction of Box Culvert at Bhurunga River, most of work consists of Costruction of Box culvert and River Training under National Competitive Bidding procedures. The estimated amount for the works is Rs. **93,47,751.45** inclusive of VAT.
- 2. Eligible Bidders may obtain further information and inspect the Bidding Documents at *Kanakai Municipality*, *Jamunbari Jhapa*, *Ph 023-401144*, *401155* or may visit PPMO website <a href="www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a>.
- 3. A complete set of Bidding Documents may be purchased from the office *Kanakai Municipality* by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, Tax clearance up to FY 073/074 ,VAT/PAN registration certificate upon payment of a non-refundable fee of *Rs.* 3,000 till 19<sup>th</sup> of Ashwin, 2075 during office hours.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site <a href="https://www.bolpatra.gov.np./egp">www.bolpatra.gov.np./egp</a>, Bidders, submitting their bid electronically, should deposit the cost(as specified above) of bidding document in the office's account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. - 4. Pre-bid meeting shall **not** be held.
- 5. Sealed or electronic bids must be submitted to the office *Kanakai MunicipalityI* by hand/courier or through PPMO website <a href="https://www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a> on or before 12:00 Noon on 21<sup>st</sup> of Ashwin, 2075. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on 21st of Ashwin, 2075 at the office of Kanakai Municipality. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of Rs. 2,50,000.00 deposited at dharauti account No. 14703000000003000002 on behalf of of Kankai Municipality ,Surunga at Nepal Bank Limited or bid bond authorized from a recognized 'A' Class commercial bank of Nepal, which shall be valid for minimum 30 days beyond the bid validity period.
- 7. Bidders' must have the work experience of Construction of at least one RCC bridge or RCC culvert having span not less than 15m. Others evaluation and eligibility criteria are as mention on bid document.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
