3. Bidding document may be purchased by eligible Suppliers **till 2075/07/09** on the submission of a written application and upon payment of a non-refundable fee of **Rs.3000.00**. Up to date Firm/Company Registration Certificate, VAT and PAN Registration Certificates, Tax Clearance Certificate of FY 2073/74 and Power of Attorney are also mandatory along with the application.
4. Bidding document must be submitted to the above office on or before **12:00 Noon on 2075/07/11**. Bidding document received after this deadline shall not be accepted.
5. Bidding document must be valid for a period of **90 days** after opening of Bidding document and must be accompanied by Cash Security or Bank Guarantee from Class A commercial bank, amount of **Rs. 93,000.00**, which shall be **valid for 120 days** after opening of the Bidding document.
6. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No **1470300000003000002** at **Nepal Bank Limited Surunga Branch** and submit the receipt of the deposited amount of cash along with the Bidding document.
